- Require a path to commercialization
- Are seeking Innovative ground breaking novel concepts or ideas which help them reach their goals

 All SBIR programs provide priority position for sole source sales to contracting agencies (DOT, NASA, DOD, DHS)

### **About the ARC WA NSF Assistance Program**

- ✓ ARC WA offers two no-cost NSF Phase 0 Cohorts each year
- ✓ Cohort participants must be registered to do business in Washington State
- ✓ First time applicants only
- ✓ Applicant must meet the standard eligibility requirements for the SBIR program
- ✓ Applicants must be registered in SAM and have an accepted project pitch before cohort start date

#### **Cohort Dates**

#### **Spring: May - July**

(eligible participants to be determined by May 1)

#### Fall: September - November

(eligible participants to be determined by Sept 1)

- There is limited availability.
- Eligible Cohort Participants will be determined on first come first serve basis.

## On Preparing a Project Pitch

Successful project pitches will result in an invitation from NSF to submit a full proposal.

ARC WA requires an invitation from NSF to submit a proposal before participation in a cohort.


